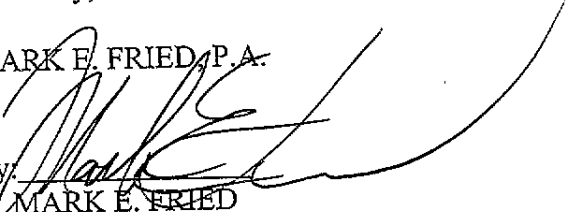

Pursuant to the provisions of Sections 607.1003, and 607.1006, Florida Statutes, the undersigned sole shareholder adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is I2I DIGITAL PRINTING, INC.
2. The following Amendments to the Articles of Incorporation were adopted by the unanimous vote of the Shareholder of the corporation on July 18, 2000, in the manner prescribed by the Florida General Corporation Act:

ARTICLE I- NAME
