**ARTICLES OF INCORPORATION
OF
HIGH POINT TRADE TECHNOLOGY, INC.**

(a Florida corporation)

THE UNDERSIGNED, acting as sole incorporator of **HIGH POINT TRADE TECHNOLOGY, INC.**, under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is **HIGH POINT TRADE TECHNOLOGY, INC.**

ARTICLE II

Principal Office and Mailing Address

The principal office and mailing address of the corporation is 400 High Point Drive, Suite 600, Cocoa, FL 32926. The location of the principal office shall be subject to change as may be provided in bylaws duly adopted by the corporation.

ARTICLE III

Shares

The corporation shall have authority to issue Two Million (2,000,000) shares of Common Stock, \$0.0005 par value per share. Such authorized Common Stock shall be divided into two classes designated as Class A Common Stock and Class B Common Stock, with each class consisting of One Million (1,000,000) shares. The rights and preferences of the shares of each class shall be identical except that the holder of shares of Class A Common Stock shall be entitled to one (1) vote per share on all matters submitted to a vote of the shareholders of the corporation, and the holders of shares of Class B Common Stock shall not have voting rights.

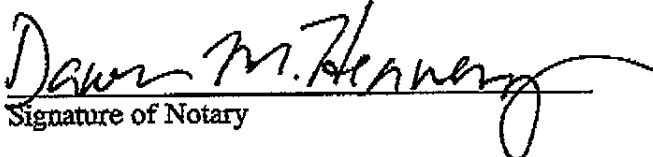
