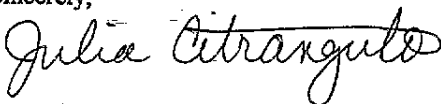
Dear Mrs. Shepard;

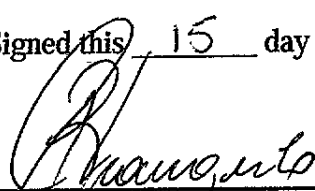
