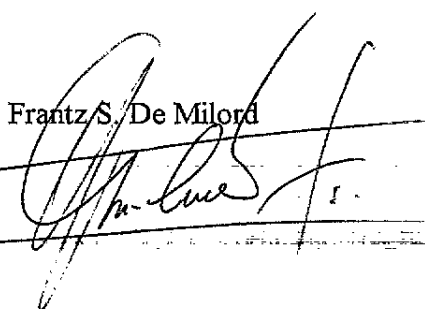

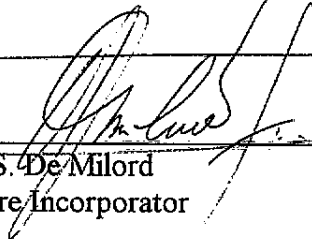
ARTICLE IX. INITIAL BOARD OF DIRECTORS

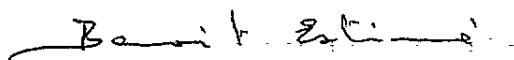
