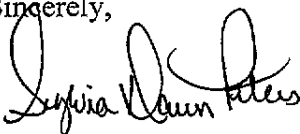

FOR

Corporate Name

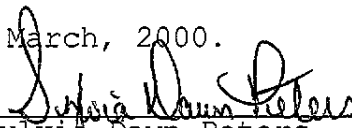

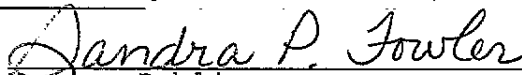

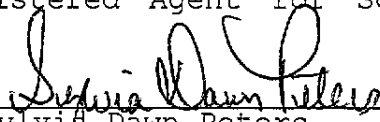
