We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the STATE OF FLORIDA, by and under the provisions of the statutes of the STATE OF FLORIDA, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

**ARTICLE I  
NAME**

The name of the corporation shall be:

**ARTICLE II  
GENERAL NATURE OF BUSINESS**

The corporation may engage in any activity or business authorized and permitted under the laws of the UNITED STATES OF AMERICA and the STATE OF FLORIDA.

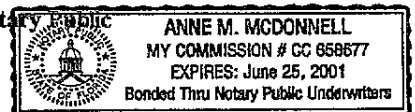
