ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation incorporated hereunder shall be All

ARTICLE II

The principal place of business and mailing address of the above-named corporation shall be at 1960 N.E. 45th Street, Ft. Lauderdale, FL 33308.

ARTICLE III

The primary purpose for which this corporation is organized is to design, develop, and implement data systems that provide customers with a means to store, represent, and manipulate information and deploy a structured user interface that allows access to the general consumer market; notwithstanding the foregoing specific statement of purpose, the corporation reserves the right to transact any and all business which a corporation can lawfully transact within the State of Florida and any other state in which this corporation does business and to do all things necessary or convenient to carry out its business and affairs.

ARTICLE IV

The number of shares of stock authorized to be issued pursuant to this incorporation is as follows:

- One Hundred (100) shares of Class A voting common stock;
- 2. One Hundred (100) shares of Class B non-voting common stock.

Nothing shall prohibit the corporation from authorizing issuance of additional shares of stock, including all classes of common or preferred stock, with any rights the Board of Directors deems appropriate at any time in the future.

ARTICLE V

The names and addresses of the initial officer(s) and director(s) are as specified in the corporation bylaws.

- (10) To elect directors and appoint officers, employees, and agents of the corporation and define their duties, fix their compensation, and lend them money and credit;
- (11) To make and amend bylaws, not inconsistent with its articles of incorporation or with the laws of this state, for managing the business and regulating the affairs of the corporation;
- (12) To make donations for the public welfare or for charitable, scientific, or educational purposes;
- (13) To transact any lawful business that will aid governmental policy;
- (14) To make payments or donations or do any other act not inconsistent with law that furthers the business and affairs of the corporation;
- (15) To pay pensions and establish pension plans, pension trusts, profit-sharing plans, share bonus plans, share option plans, and benefit or incentive plans for any or all of its current or former directors, officers, employees, and agents and for any or all of the current or former directors, officers, employees, and agents of its subsidiaries;
- (16) To provide insurance for its benefit on the life of any of its directors, officers, or employees, or on the life of any shareholder for the purpose of acquiring at his or her death shares of its stock owned by the shareholder or by the spouse or children of the shareholder; and

- (7) To make contracts and guarantees, incur liabilities, borrow money, issue its notes, bonds, and other obligations (which may be convertible into or include the option to purchase other securities of the corporation), and secure any of its obligations by mortgage or pledge of any of its property, franchises, and income
