ARTICLE ONE

The name of the corporation is ANGELFISH INTERNATIONAL, INC. The principal address of the corporation is: 5020 N.W. 125th Avenue, Coral Springs, Florida 33076.


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
