**ARTICLES OF INCORPORATION OF
DATA TREE INTERNATIONAL, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1. The name of the is Data Tree International, Inc. (the "Corporation").

ARTICLE 2. The principal place of business and mailing address of the Corporation is Data Tree International, Inc., c/o Riki Anne Wilchins, 1537 Meridian Avenue, No. 7, Miami Beach, FL 33139.

ARTICLE 3. The number of shares of stock of the Corporation authorized to be issued and outstanding at any one time is 100. The Corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than 35 persons. Stock will be issued and transferred only to (i) natural persons, (ii) estates, or (iii) a trust satisfying the requirements of Section 1361(c)(2) (or its successor section) of the United States Internal Revenue Code. No stock shall be issued or transferred to a nonresident alien.

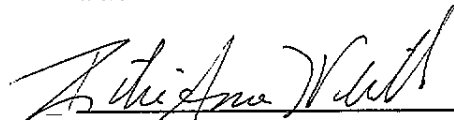
