ARTICLES OF INCORPORATION

OF

ATTORNEYS' TIMEKEEPERS, INC.

I, the undersigned, being a natural person desiring to establish a corporation under the laws of the State of Florida for the transaction of business and the promotion and conduct of the objects and purposes hereinafter stated, do make, subscribe, acknowledge and file these Articles of Incorporation and do certify as follows:

ARTICLE I

The name of the Corporation shall be ATTORNEYS' TIMEKEEPERS, INC.

ARTICLE II

The general nature of the business to be transacted and the purpose or purposes for which the corporation is organized are to perform accounting and time records of attorneys for their clients and to transact any and all other lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

This Corporation is authorized to issue 500 shares of Common Stock having a par value of \$1.00 per share.

ARTICLE V

The amount of capital with which this Corporation will begin business shall be and is in the sum of Five Hundred Dollars (\$500.00).

ARTICLE VI

The principal office of this Corporation shall be located in the City of Miami, Dade County, Florida and the street address of said principal office shall be 9310 West Flagler Street, #103, Miami, Florida 33174.

ARTICLE VII

This Corporation shall have one (1) Director initially. The number of Directors may be increased or diminished from time to time by the By-Laws but shall never be less than one (1). The name and address of the initial Director of this Corporation is:

ARTICLE VIII
