#### ARTICLES OF INCORPORATION

#### ARTICLE I

Name. The name of this Corporation is SPORTS FANS OF AMERICA ASSOCIATION, INC.

#### ARTICLE II

<u>Duration</u>. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

#### ARTICLE III

<u>Purpose</u>. The purpose of this Corporation is to engage in any activities or business permitted under the laws of the United States and the State of Florida.

#### ARTICLE IV

Address. The street address of the initial principal office and the mailing address of the corporation is: 3320 NE Kensington Place, High Springs, Florida, 32643.

#### ARTICLE V

<u>Capital Stock</u>. This Corporation is authorized to issue 50,000 shares of One Dollar (\$1.00) par value common stock.

#### ARTICLE VI

By-Laws. The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors.

#### ARTICLE VII

<u>Initial Registered Office and Agent</u>. The street address of the corporation's initial registered office and the name of its initial registered agent at that office is Peter C.K. #### ARTICLE VIII

<u>Initial Board of Directors</u>. The number of Directors of the corporation shall be established from time to time by the Bylaws, but shall never be less than one. The name and address of the initial Director of the corporation is:

#### **ARTICLE IX**

Pre-emptive Rights. Each shareholder of this corporation shall have the first right to purchase shares of any class, kind or series of stock in this corporation that may from time to time be issued, whether or not presently authorized, including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares pre-empted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his pre-emptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
