That the persons named herein are all natural persons of the age of twenty-one (21) years or more, and for the purpose of forming a profit corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation for such Corporation.

ARTICLE I.

The name of the corporation is Sands Point Motel, Inc.




