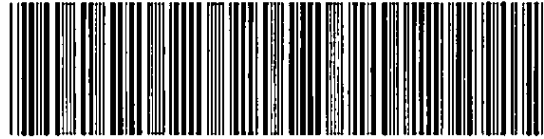

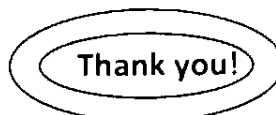

These Articles of Conversion are submitted to convert the following described Florida corporation into a business entity formed under the laws of another jurisdiction in accordance with Section 607.11933, Florida Statutes.

1. The name of the Florida corporation converting into the resulting business entity is ACJR Investments, Inc. (the "Converting Corporation").
