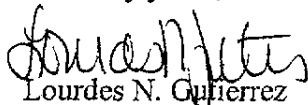

Pursuant to Section 607.1403, Florida Statutes, we, the undersigned, hereby execute, acknowledge and file the following Articles of Dissolution for the purpose of recording the dissolution of Garnet Investments Inc., a Florida corporation for profit organized under the laws of the State of Florida, to wit:

ARTICLE I - Name and Incorporation

The name of the corporation is Garnet Investments Inc. (the "Corporation"), that was incorporated under Articles of Incorporation filed with the Florida Department of State on March 3, 2000 and assigned document number P00000024946.

ARTICLE II-Resolutions of the Shareholders
