To whom this may concern at the Division of Corporations;

Lovol Corporation missed the original filing deadline of May 1st 2001, a second notice from the State was never received. On October 22nd, 2001(Monday) the notice of Administrative Dissolution was received, and I (Joseph Linartas) immediately made a phone call to your offices. After explaining that I never received a second notice, your employee told me it would be best to write a letter and explain the situation.

It was my understanding that after the May 1st 2001 deadline, the corporate UBR was \$550.00, I was not made aware that there was a September dissolution deadline. <u>I also never received any notice other than the original notice (first notice) mailed to me.</u>

My only explanation for never receiving the second notice sent by the State is that our mail does come to us in a cluster box(60 mail box's in one location). The post office has been known to mis-deliver mail on occasion. Fortunately I did receive the notice of dissolution and am taking immediate action. Had I been made aware the State had a September deadline for dissolution I would have filed the UBR as required.

This was the first year ever Lovol Corporation had to file a UBR, and therefore I ask that the amount of \$550.00 be accepted, and that Lovol Corporation be reinstated with the State. In the future all deadlines will be met on time by Lovol Corporation.
