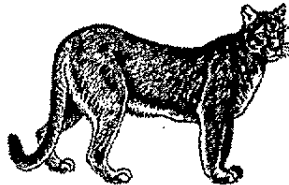

Articles of Incorporation For Dirty South Entertainment, Inc.

Following Chapter 607 of the Florida Statutes, the undersigned does hereby submit these Articles of Incorporation for forming a profit corporation.

Article 1 - Name and Principal Office

The name of the corporation is **Dirty South Entertainment, Inc.** The corporation's mailing address is 8551 West Sunrise Blvd., Ste. 102, Plantation, FL 33322-4007. The corporation's physical address and principal place of business is 8004 NW 154 St., Ste. 135, Miami Lakes, FL 33016.

Article 2 - Duration

The duration of the corporation is perpetual.

Article 3 - Purpose

The corporation shall engage in a movie and video entertainment business or any business permitted under Florida Statute 607.0301.

Article 4 - Shares

The corporation may issue an aggregate one thousand common shares of capital stock with a minimum par value of \$1.00. These common shares will have pre-emptive rights following Florida Statute 607.0630. The Florida Documentary Stamp Tax of \$3.50 will be paid directly to the Florida Department of Revenue by certificate of registration 650584824-16-001.


Article 5 - Start of Business

The corporation will start once the corporation has issued at least one common share in exchange for one thousand dollars in cash, property, or services rendered.

Article 6 - Registered Agent and Registered Office

The name of the corporation's first registered agent is **Jumpingjaxtax.com, Inc.** Its address is 8551 West Sunrise Blvd., #102, Plantation, FL 33322-4007.

As registered agent, **Jumpingjaxtax.com, Inc.** accepts service of process for the above corporation at the place designated in these articles of incorporation. It accepts this appointment and agrees to act in this capacity. It further agrees to comply with the provisions of all Florida statutes relating to the proper and complete performance of his duties. **Jumpingjaxtax.com, Inc.** is familiar with and accepts the obligations of registered agent for this corporation.

Article 8 – Powers of the Directors


The Board of Directors shall make, alter, or repeal the Bylaws of the corporation without restrictions of their powers conferred by statute.
