ARTICLES OF INCORPORATION
OF
AQUAFIBER PACKAGING CORPORATION

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is: AQUAFIBER PACKAGING CORPORATION.

ARTICLE II:

COMMENCEMENT AND DURATION OF CORPORATE EXISTENCE

The corporation shall commence its corporate existence on the date of subscription and acknowledgment of these Articles of Incorporation, and shall have perpetual existence.

ARTICLE III:

GENERAL PURPOSE

The purpose for which the corporation has been formed is: To engage in and transact any and all lawful business permitted under the laws of the State of Florida and of the United States.

ARTICLE IV:

CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to issue is Ten Million (10,000,000) shares of common stock having par value of one thousandth of one dollar (\$.001) per share **AND** Ten Million (10,000,000) shares of preferred stock having par value of one thousandth of one dollar (\$.001) per share. The consideration to be paid for each share shall be fixed by the Board of Directors. Common stock of the corporation shall be issued as "small business corporation" stock in accordance with a plan or plans under the provisions of Section 1244 of the Internal Revenue Code of 1954.

ARTICLE V:

INITIAL PRINCIPAL PLACE OF BUSINESS AND
INITIAL REGISTERED OFFICE AND AGENT

AMENDMENT

ARTICLE VIII:

SIGNING OF DOCUMENTS BY CORPORATION

All bonds, notes, other evidences of indebtedness, mortgages, deeds, contracts, and all documents of this corporation shall be fully authorized and effective when signed in its name in the presence of two witnesses by the President, or by a Vice President, or by the President and the Secretary; and no such instrument shall be valid without being so signed unless otherwise stated by the Board of Directors. The Corporate Seal or a blank seal acting as a substitute for the "Corporate Seal" shall be used in executing all documents signed by the President and a Vice President.


ARTICLE IX:

The Effective date of Incorporation for Aquafiber Packaging Corporation shall be 16 March, 2000.


