## ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

### ARTICLE I

#### Name of Corporation

The name of this corporation shall be: L.R.A. Productions, Inc.

### ARTICLE II

#### Nature of Business

The general nature of the business to be transacted by this corporation is to produce audio/video tapes for sale, distribution, promotion, dissemination to the public, as well as any and all other business permitted under the laws of the State of Florida.


