The undersigned incorporator(s) hereby adopt the following Articles of Incorporation:

- I. CORPORATE NAME - PUNIT CORPORATION

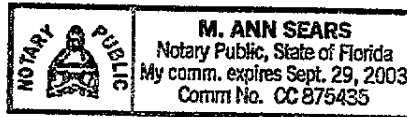
