INDEMNIFICATION


This Corporation shall indemnify any Officer or Director, of any former Officer or Director, to the full extent of the law.



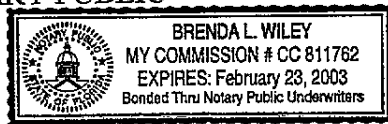


