

# ARTICLES OF INCORPORATION

## ARTICLE I - NAME

The name of the corporation is TIMELESS CAPERS, INC.

#### **ARTICLE II - DURATION**

As provided in Florida Statutes, Chapter 607, this corporation shall exist in perpetuity.

#### **ARTICLE III - PURPOSE**
