ARTICLE XII.



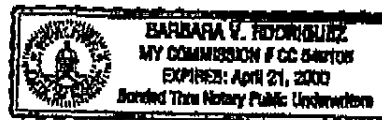
