ARTICLES OF INCORPORATION OF

FLORIDA FINE FLOORING, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

FLORIDA FINE FLOORING, INC.

ARTICLE II

This corporation shall have the power to engage in any lawful activity for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE III

The aggregate number of shares that the corporation shall have authority to issue and to have outstanding at any one time is 1,000,000 shares. All such shares shall be of a single class, designated as common.

In addition, the corporation shall pay for or reimburse any expenses incurred by such_persons who are parties to such proceedings, in advance of the final disposition of such proceedings, to the full extent permitted by the Florida Business

ARTICLE VII

The Florida Control-Share Acquisition sections of the Florida Business Corporation Act (§§ 607.0901 through 607.0903) shall not be applicable to this corporation.

ARTICLE VIII

The bylaws of the corporation may be amended by majority vote of either the directors or the shareholders.
