ARTICLE I:

Name of Corporation: **Plummor of Central Florida, Inc.**

ARTICLE II:

NATURE OF BUSINESS: The purpose of the corporation is to engage in or transact any and all lawful transactions, activities, or business permitted under the laws of the United States, the State of Florida or any other State, Country, Territory or Nation.

ARTICLE III: CAPITAL STOCK

The maximum number of shares of stock that this corporation, **Plummor of Central Florida, Inc.**, is authorized to have outstanding at any one time is 1,000 shares of common stock having par value of \$1.00 per share.

ARTICLE IV:

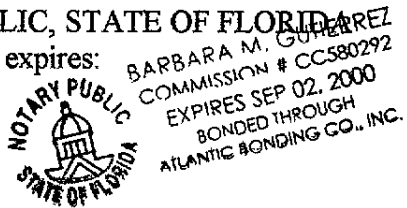
