## ARTICLE TWO

#### **NATURE OF BUSINESS:**

GOODS FOR SALES (DISCOUNT STORES)

THIS CORPORATION MAY ENGAGE IN ANY ACTIVITY OR BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATES OF AMERICA.
