ARTICLES OF INCORPORATION

ARTICLE I - NAM_

The name of this corporation is Rave WHEELS, Inc., and its address is 1743 Plantation Circle S.E., Palm Bay, Florida, 32909

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the date of subscription and acknowledgement hereof as provided by Florida statute 607.0203.

This corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
