ARTICLES OF INCORPORATION

OF

BISCAYNE SELF STORAGE CORP.

The undersigned, acting as incorporator of BISCAYNE SELF STORAGE CORP., pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is:
