ARTICLES OF INCORPORATION OF ACCU CREDIT CORPORATION

WE, THE UNDERSGINED, natural persons of the age of eighteen (18) years or more, acting as incorporators for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.
