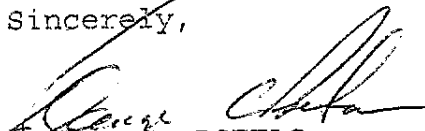

ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby files for record the following Articles of Incorporation:-

ARTICLE 1 - NAME AND ADDRESS

The name of the corporation shall be:

PYROLL MANAGEMENT INC.

The principal place of business of this corporation shall be:

7134 Mayfield Drive
Port Richey, FL 34668

ARTICLE 2 - NATURE OF BUSINESS

This corporation shall manage property for foreign and domestic homeowners such as pool service, mail referral, cleaning service, lawn service, security watch, prepaid billing service for utilities, premises maintenance, and may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE 3 - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding is 500 shares of common stock having \$1.00 par value per share.

ARTICLE 4 - REGISTERED AGENT AND ADDRESS

The street address of the initial registered office of the corporation shall be:

The initial registered agent of the corporation is Thomas Loosz.

ARTICLE 5 - TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE 6 - PREEMPTIVE RIGHTS

Every shareholder upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds shall have the right to purchase his pro-rata share thereof at the price at which it is offered to others.

ARTICLE 7 - BUY BACK OPTION

If a shareholder or anyone receiving shares by sale or inheritance, desires to sell his stock during his lifetime, he shall give the other stockholders and the secretary of the corporation written notice of such desire, and the other stockholders shall have the right to purchase such stock at any time within thirty days after such notice at such terms as the selling stockholder may be offering.

ARTICLE 8 - SPECIAL PROVISIONS

It is the intent of the incorporation that the corporation will qualify under Section 1244 of the Internal Revenue Code and that the corporation will file as a Subchapter S corporation.

ARTICLE 9 - DIRECTORS

The requirement for directors of the corporation shall be dispensed with and all powers and duties otherwise conferred upon corporate directors shall be performed and exercised by the president of the corporation.

ARTICLE 10 - OFFICERS

The names and addresses of the initial officers of the corporation shall hold office for the first year of the corporation, or until their successors are elected or appointed are:

ARTICLE 13 -- BYLAWS

The initial Bylaws shall be adopted by the Board of Directors. The power to alter, amend or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the shareholders.

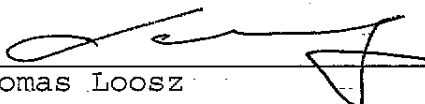
ARTICLE 14 - AMENDMENT

This Corporation may have other offices, agencies and branches at such places either within or without the State of Florida as may be determined by the Board of Directors.

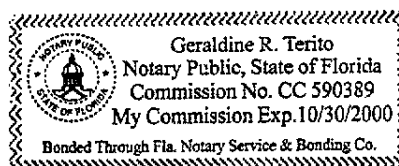
