ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION OF
C.R.M., INC.

Pursuant to the provisions of Section 807.1006 of the Florida Business Corporation Act, the Articles of Incorporation of C.R.M., INC. (the "Corporation") are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is C.R.M., INC. The Articles of Incorporation were filed on March 14, 2000. The assigned document number is P00000025948.


SECOND: Article I of the Articles of Incorporation, as amended, is hereby deleted in its entirety and the following Inserted in lieu thereof:

"The name of the Corporation is C.R.M. FINANCIAL, INC."

THIRD: The foregoing amendment was adopted by Joint Unanimous Written Consent of the Board of Directors and the Shareholders dated as of June 27, 2016.

FOURTH: Except as hereby amended, the existing Articles of Incorporation of the Corporation shall remain in full force and effect.
