**ARTICLES OF INCORPORATION  
OF  
FEATHER OAKS, INC.**

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, does hereby act as the incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing and forming a business corporation under the Florida Business Corporation Act.

**ARTICLE I**

Name. The name of the corporation is Feather Oaks, Inc.

**ARTICLE II**

Effective Date and Duration. The existence of the corporation shall begin on March 6 ~~1999~~, and shall be perpetual.
