ARTICLE X

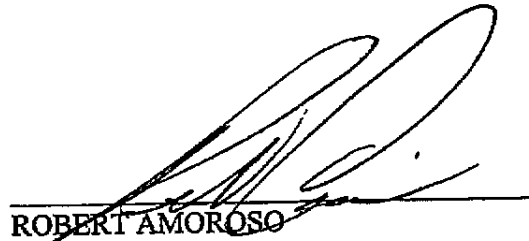

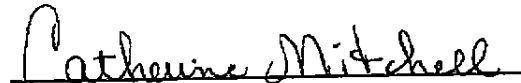

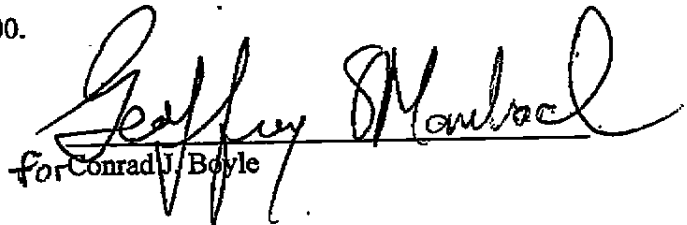
