The name of the Corporation is set forth above.

**2. Principal Office and Registered Agent.**

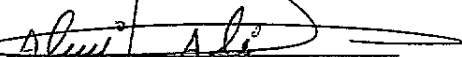
**6. Existence.**

**7. Liability of Stockholders.**

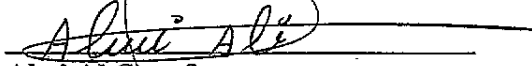
The private property of the stockholders shall not be subject to the payment of corporate debts.

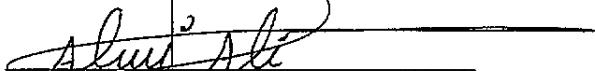
