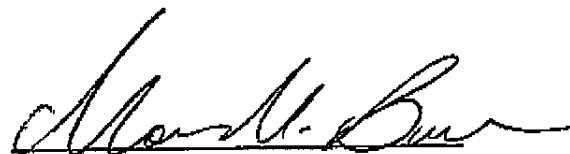
ARTICLES OF INCORPORATION
