

**ARTICLES OF INCORPORATION  
OF  
DEBRA HUTCHINSON INTERIORS, INC.**

**ARTICLE I  
NAME**

The name of this Corporation is Debra Hutchinson Interiors, Inc.

**ARTICLE II  
DURATION**

This Corporation shall have perpetual existence. The effective date of this Corporation shall be the date of filing of these Articles.

**ARTICLE III  
PURPOSE**


