ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I NAME

The name of the corporation is:

ARTICLE III SHARES

All of said stock shall be payable in cash, real or personal property, or labor in lieu of cash, at fair market value. The following shares shall be issued initially:

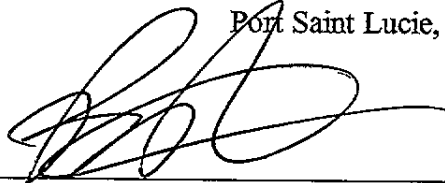

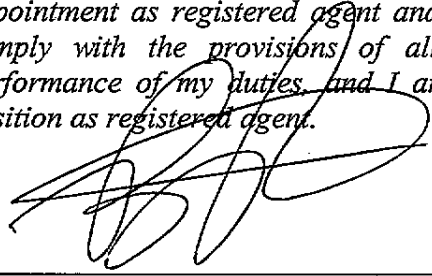

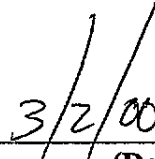
