I, the undersigned incorporator, do hereby form a corporation for profit inder the General Laws of the State of Florida, and pursuant to §607.0202, Florida Statutes, these articles of incorporation provide that:

ARTICLE I

The name of the corporation shall be MIKE DOYLE PAINTING COMPANY

ARTICLE II

The location of the principal place of business shall be 570 Lafitte Rd., Summerland Key, Florida. The mailing address of this corporation shall be 570 Lafitte Rd., Summerland Key, Florida, 33042.

1.
