
Dear Ms. Ashton,

I am in receipt of your letter to Grooming Gallery, Inc. with reference to the UBR filed **TIMELY!**

This taxpayer filed their first year UBR form timely as this office put in the Federal ID number and the additional information. We, in an effort to get the form done promptly, unintentionally forgot to put in the title of Angelo Leto. The UBR was mailed timely as you can see by the copy of the cancelled check, which your office put through your bank on March 12, 2001.

The taxpayer, as well as this office, was unaware of any missing information as the UBR (sent back by FDOR) was not received prior to the filing deadline. It is unfair to penalize a taxpayer if they do not have ample time to correct or include missing information to avoid a penalty. When the UBR was received, after May 1, asking for additional information, that information was corrected on the form and promptly sent back to you.
