Article I of the Articles of Incorporation shall be deleted in its entirety and replaced by the following:


ARTICLE I. NAME; ADDRESS

The name of the corporation shall be Focalscope, Inc.


ARTICLE II OF AMENDMENT

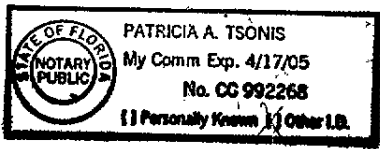
