ARTICLES OF INCORPORATION

OF

DELMOR INVESTMENT CORP.

<u>ARTICLE I - NAME</u>

The name of the corporation is Delmor Investment Corp. (hereinafte called the "Corporation").

ARTICLE II - PURPOSE
