# ARTICLES OF INCORPORATION

**OF** 

### TELEFONICA USA, INC.

# ARTICLE I

The name of the corporation is TELEFONICA USA, INC. (the "Corporation")

### **ARTICLE II**

The address of the principal office and the mailing address of the Corporation is 1221 Brickell Avenue, Miami, Florida 33131.

#### ARTICLE III
