**ARTICLE VI. REGISTERED AGENT**



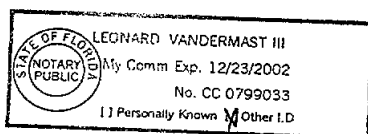


