**ARTICLES OF INCORPORATION**  
**OF**

The undersigned, acting as incorporator of **ADVANTAGE IN SUPPORT COORDINATION, INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is **ADVANTAGE IN SUPPORT COORDINATION, INC.**

**ARTICLE II. ADDRESS**

The mailing address of the corporation is 7501 S.W. 16 Street, Miami, Florida 33155.

**ARTICLE III. COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

The name and street address of the incorporator are Lissette E. Lorenzo, 7501 S.W. 16 Street, Miami, Florida 33155.

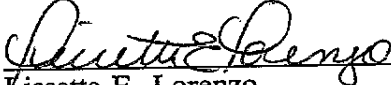
#### **ARTICLE VIII. BYLAWS**
