**ARTICLE I**  
**NAME**

This Corporation shall exist perpetually.

**ARTICLE III**

This Corporation is organized for the purpose of operating as an Automotive Repair and Service Center, providing Repairs and Maintenance to all types of Motor Vehicles.

**ARTICLE IV**  
**CAPITAL STOCK**

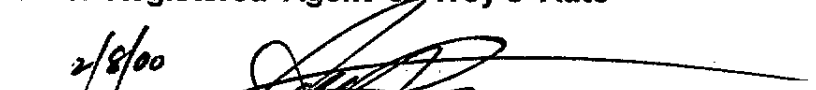

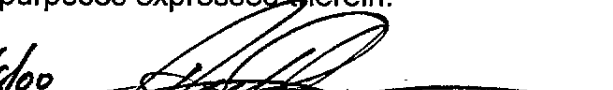

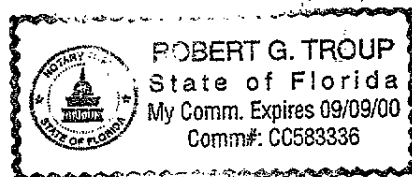
