ARTICLES OF INCORPORATION

I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I.

<u>Name</u>

The name of this corporation shall be:

ARTICLE II.

Existence of Corporation

This corporation shall begin on the $3^{\rm rd}$ day of March, 2000, and shall thereafter have perpetual existence.

ARTICLE III.

Purposes

The corporation may engage in the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV.

General Powers

- d. To lend money to, and use its credit to assist, its officers and employees in accordance with Section 607.141, Florida Statutes.
- e. To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof.

- f. To make contracts and guaranties and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
- g. To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds_so loaned or invested.
- h. To conduct its business, carry on its operations, and have offices and exercise the powers granted by law.
- i. To elect or appoint officers and agents of the corporation and define their duties and fix their compensation.
