
ARTICLE X



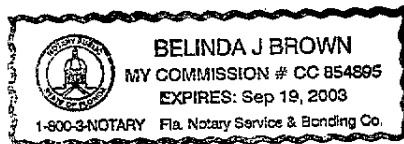


