ARTICLE ONE - NAME

ON CHAINS CONTRACTOR

The name of this corporation is: New Tampa Health And Fitness Center, Inc.

ARTICLE TWO - DURATION: EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of the date of execution of these Articles of Incorporation.

ARTICLE THREE - PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE FOUR - CAPITAL STOCK
