Dear Sir or Madam,

I am the president of a small woman-owned business (S-Corporation) that just incorporated last year. At this time, the corporation employs only myself as a part-time employee so the company cannot afford to hire an accountant or bookkeeper even as a part time employee. All of our accounting, taxes, etc. must, therefore, be done by myself or my husband in our spare time. Given the limited amount of time that we can devote to accounting, our limited backgrounds with accounting, and the fact that this is our first year in business, we neglected to realize until this week that we needed to submit the 2001 Uniform Business Report.

While we are anxious to rectify this situation as soon as possible, the \$400 penalty associated with filing this report late would be financially devastating for our business. This fee, for a company our size, represents the majority of operating resources that we maintain for executing our current business and pursuing future business to sustain our company and maintain its existence.

Yesterday I contacted an individual from your office and explained our situation to her. She suggested that I send our Uniform Business Report with the standard filing fee and mail it to the address above along with an explanation of why we did not submit the form by the May 1, 2001 deadline. Given the extenuating circumstances that I have described, I would like to respectfully request that you waive the \$400 late filing fee for my company so that we may continue to exist and provide opportunities and revenue to the state of Florida. Please contact me if this is not possible so that we may determine what is necessary to resolve this situation.
