ARTICLE I: NAME

The name of the corporation shall be: E.N. Educators, inc.

ARTICLE II: PURPOSE

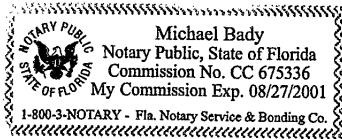




