

RESTATED ARTICLES OF INCORPORATION OF FLORIDA COMMUNITY BANKSHARES, INC.



Pursuant to the provisions of the Florida Financial Institutions Codes and Section 607.1007, Florida Statutes, Florida Community Bankshares, Inc. adopts the following Restated Articles of Incorporation which shall take effect as of 11:57 p.m., Eastern Standard Time, on November 8, 2019.

ARTICLE I

The name of the corporation shall be Florida Community Successor Bank and its place of business shall be located at 1603 SW 19th Avenue, Ocala, Florida 34471.

ARTICLE II

The corporation shall be organized as a successor institution in accordance with Sections 658.40(4) and 658-42(2), Florida Statutes.

ARTICLE III

The total number of shares authorized to be issued by the corporation shall be 3,000,000. Such shares shall be of a single class of common stock and shall have a par value of \$0.01 per share. As of the filing of these Restated Articles of Incorporation, the corporation shall have (i) at least \$13,642 of paid-in common capital stock divided into 1,364,110 shares, (ii) surplus of at least \$18,232,825, and (iii) undivided profits (less treasury stock) of at least \$49,513,315, all of which (capital stock, surplus and undivided profits) paid in cash.

ARTICLE IV

The term for which said corporation shall exist shall be one (1) year.

ARTICLE V
